

## Accessibility for Ontarians with Disability Multi-Year Accessibility Plan – Integrated Accessibility Standards (“IAS”)

In 2005, the Accessibility for Ontarians with Disabilities Act (AODA) was enacted by the Ontario government. The AODA's Integrated Accessibility Standards Regulations mandate that companies create and uphold a multi-year accessibility plan, detailing their dedication to addressing accessibility issues.

This document signifies BlueRock Therapeutics ULC's pledge to create an accessible and inclusive environment for individuals with disabilities.
